Re: Load Layover Option for Pending Gate Reservations

Dear Valued Customer:

Pacer Stacktrain is keenly aware of the difficulties our customers are currently facing getting gate reservations on a timely basis, particularly in the high demand California outbound markets. We apologize for this inconvenience. We are taking a number of steps to maximize both the number of gate reservations we have available to offer to our customers as well as assuring these allocations are distributed in a efficient and equitable manner.

Effective Monday, October 10, 2005, we are taking the additional step of offering our customers the option of bringing loads awaiting gate reservations to our container yard (CY) locations in both Los Angeles, CA and Lathrop, CA, where dedicated space will be allocated for holding these loads. The Pacer Stacktrain per diem clock will be stopped upon ingate and will remain stopped while the container is on our CY. In order to keep our CY's fluid we will allow 48 hours free time for each container. Weekends will not count against CY storage free time. At the expiration of free time, a \$25 per day storage charge will be assessed. We will set up a process to work with our customers who have loads at our CY's with pending gate reservations to move these loads out as quickly as possible.

Simply direct your drayman to ingate the appropriate loads at the locations detailed below. The unit will be inspected and secured. When your confirmed gate reservation is available for a particular container or containers, simply use the attached form to fax release authorization for the respective container(s) to be picked up by your specified drayman.
