**RE: Announcing New 53' FAK Service between Chicago, IL and Hermosillo, SON, MX,  
effective August 14, 2006**

Dear Valued Customer:

In an effort to better serve you, Pacer Stacktrain is continuing to add new service origins and destinations. Effective August 14, 2006, we will be offering FAK service between Chicago, IL and Hermosillo, SON, MX. We will restrict the service to 53' 110 equipment only; 48' equipment will not be allowed. This service will use the UP between Chicago and Nogales and FXE between Nogales and Hermosillo. In Mexico, the name of the FXE rail ramp is Hermosillo Station. Containers will clear Mexican Customs at Hermosillo Station. Container pick-up and delivery will be at the Dynatech ramp.

To ensure a smooth continuous ride, freight will be pre-cleared for customs in Chicago (southbound) or Hermosillo (northbound) before the containers will be loaded onto the train. On transborder movements, always use Double Stack Service (phone: 915-633-6104) as the U.S. Freight Forwarder and Fernando Ramos Casa (phone: 915-633-6104) as the Mexican Customs Broker.

We strongly encourage you to review our Mexico Guide posted on our website. It is a comprehensive downloadable document that provides instructions, helpful hints and examples of forms required for doing transborder business.
