In an effort to better serve you, Pacer Stacktrain is continuing to add new service origins and destinations. We are pleased to announce that effective September 22, 2006 we will be offering service between the U.S. and Mexican origins and destinations listed below. This service is for 48' and 53' equipment. Ramp-to-ramp pricing is the same for both equipment sizes and the FAK rates are provided below.

To insure a smooth and continuous southbound move for loads which require Customs clearance in Mexico, it will be necessary to pre-clear Mexican Customs before a container is loaded onto the train at Norfolk Southern's Inman Terminal. Customs clearance for southbound moves will be performed by:

Required documentation for pre-clearance should be faxed to the above fax number.

Shipments originating in Mexico will be checked to ensure that they are AMS compliant before they can be loaded onto a train bound for the U.S. Northbound rates are subject to equipment availability and/or street-turns made by IMCs. Empty equipment from northbound moves must be terminated at our Morgan Southern Container Yard in Atlanta and not at the NS Inman Terminal.

Please check our website for ramp information, business hours and schedules. We strongly encourage you to review our Mexico Guide posted on our website. It is a comprehensive downloadable document that provides instructions, helpful hints and examples of forms required for doing cross-border business.
